

Nu'uanu Congregational Church Capital Campaign - Ways to Give

Built on a rich history of ministry to the community, Nu'uanu Congregational Church is preparing for the future of our ministry via our Faith, Hope, & Mission Capital Campaign. Our investment in renewing the sanctuary will create a safer, more inclusive space that lends itself to greater use by the community.

Each of us, as part of the NCC Ohana, is asked to prayerfully consider how we can contribute to the project with as generous a gift as possible, payable over the next three years. Most of us will be making this financial commitment using accumulated assets, not the funds we need for day-to-day living.

Here are some alternatives of providing a generous pledge to the Capital Campaign. Here are some ideas; if you would like more information about any of these options, please use the form on the opposite side of this page.

Employer Matching Gift

Inquire if your employer can make a gift to the Capital Campaign and list that amount as part of your pledge.

Credit Card Payments

Those who optimize credit card reward points may wish to pay their pledge by credit card on the Nu'uanu Congregational Church website. Please consider adding the transaction fees for your credit card (2.75% for Visa, Mastercard, Discover or 3.5% American Express) to the donation. Your coverage of the transaction fees ensures that all funds raised are used for the capital campaign projects.

IRA Distribution

If you are drawing funds from an IRA account, request a Qualified Charitable Distribution. This ensures the donation goes directly to the church, thus avoiding taxes.

A Gift of Securities

You can ask your broker to transfer shares of stock electronically from your account directly into the Church's account. (Please contact the Church Office for the Church's brokerage account number.) Remember to ask your broker to identify you as the donor of the shares of stock so that you receive both the credit for the gift and the official acknowledgement letter from the Church.

Convert Jewelry, Artwork, or Real Estate

You may have appreciated assets such as jewelry, artwork or property that you would like to sell and then donate the proceeds to the Church. Special arrangements may need to be made with regard to real estate to avoid potential capital gains tax.

Life Insurance

The insured can contribute a paid-up policy to the Church.
